    - Lessons learned: south waste water treatment facility has spiked in carbon dioxide levels. (Apollo Chem) Unknown cause being investigated.
    - Kiser Roth during hard freeze in Dec had a valve leak that released chemicals. Investigation concluded to let valves air dry to prevent reoccurrence.
    - Chandler Concrete had truck accident, wanted to praise first responders and agencies involved with handling of event and being able to see emergency services in response to emergencies.

    - Q1 and Q2 presentation built up to Q3 presentation to show the importance of the LEPC and Hazmat response and why Tier II reporting is important.

- Presentation
  - Weaver Fertilizer Plant Fire- Robert Reece WSFC EM
    - Jan 31-Feb 7, 2022
    - 10x the amount of West Texas, of ammonium nitrate stored plus finished fertilizer product. (highly combustible/explosive material)
    - High risk industries should evaluate how to help those they would affect prior to events. Issues noted with monetary disbursement during.
    - Evacuation was voluntary and social media blast used to communicate as well as door to door with PA systems on emergency vehicles. Assistance provided by WSTA, WSFD and WSPD to get out of the 1 mile evacuation zone.
    - 6,493 residents, 2,497 households, 412 commercial properties, and 25 manufacturing facilities affected in evacuation zone.
    - Lessons Learned: Evacuation, mandatory vs voluntary, does local ordinance give the authority to enforce. How do you notify people? Personnel Accountability Response and how do you track personnel? Plans for handling donations and how to properly disperse them. Drone operations and air space control.
