3. Guthrie Mill and Dam Designation Report

Katherine Hadley gave an overview of the property and talked about how the mill house had been moved up the hill from the dam because of flooding. She acknowledged that the mill house has changed a lot in use but the dam has not changed at all. Megan Privett suggested to focus more on the dam since it still retained its historic integrity. Katherine told the board that the mill had indeed changed a lot since it was built in 1805 and read a statement from the owner saying that they acknowledge the mill's change in use. It was brought up that it would be unlikely for the whole 5 acre property to be registered just for the dam and if the whole property was registered that might place some limitations on the owner if they would need to get Certificates of Appropriateness for any kind of change to the property. Rodney asked if staff could make a new report on the property focusing on the dam itself. Matthew replied and said they could and would look into if a survey would be needed to narrow the focus to just the dam itself. The commission decided to continue discussion during the next meeting with a revised report.

VI. ANNOUNCEMENTS

Rodney told the commission that his wife had painted 4 barns built by Katherine's grandfather Harvey Newlin and that Katherine had been compiling some history on the barns. He said there was some talk about putting all of that into a book and asked the commission if they wanted to help in any way. John Greeson said that he would love to help and also asked if the owners had considered historic designation. Katherine supported the idea and added that this could also help with potential grants. Megan added that the barns were very significant to the county and that she had worked on a project involving a Newlin barn recently.

Aric mentioned that the commission still needed a motion to approve the proclamations.
