OPIOID SETTLEMENT OVERVIEW

- The North Carolina Opioid settlement is part of a 56 billion-dollar national settlement with opioid manufacturers, distributors, and pharmacies accused of fueling the overdose crisis.
- Alamance County anticipates receiving \$16,048,499 over 18 years. Funds from these settlements will help to bring desperately needed resources to those directly impacted by the opioid epidemic.



OPIOID SETTLEMENT MENORANDUM OF AGREEMENT

- The Memorandum of Agreement (MOA) is a binding legal document incorporated into the various settlement agreements and bankruptcy resolutions.
- The MOA governs the allocation, use, and reporting requirements for opioid settlement funds.
- Every local government that receives opioid settlement funds must abide by the MOA.
- Local governments are responsible for deciding which strategies to support with settlement funds. There are two lists of strategies; exhibit A which are high-impact abatement strategies, and exhibit B lists additional remediation activities.
- Local governments are also responsible for data collection, contract monitoring, holding an annual meeting, and annual financial & impact reporting.



ELIGIBILITY

- Nonprofit organizations (proof of non-profit status is required)
- Governmental agencies
- Hospital systems
- Private Behavioral Health and Mental Health providers (including Office-Based Opioid Treatment and Opioid Treatment Providers)
- Federally Qualified Health Centers
- Colleges and Universities
- K-12 schools
- Other community-based organizations licensed to conduct business in North Carolina



ELIGIBLE OPTION & STRATEGIES

- Strategy 2: Evidence-based addiction treatment
- Strategy 3: Recovery support services
- Strategy 4: Recovery housing support
- Strategy 6: Early intervention
- Strategy 12: Reentry programs

Applicants may apply to support more than one evidence-based strategy; a separate proposal application is required for each Option A strategy.



PROGRAM REQUIREMENTS

Funded projects must:

- 1. Meet a public purpose
- 2. Identify and directly address a need related to reducing opioid overdose and related deaths through treatment, recovery, harm reduction, and other life-saving programs
- 3. Directly address health inequities, social drivers/determinants of health, and support equitable outcomes for most impacted populations.
- 4. Clearly describe specific plans to incorporate equity throughout the program.
- 5. A plan to incorporate feedback from program participants to inform program delivery
- 6. Utilize evidence-based practices
- 7. Have at least one year of experience
- 8. Make the best use of county resources
- 9. Serve residents of Alamance County
- 10. Proposals must be no greater than 2-year projects
- 11. A representative of each funded agency must attend monthly meetings with the Alamance County Health Department representative to discuss progress and data collection for their approved projects



PROGRAM EVALUATION AND MONITORING

- Records of opioid abatement fund expenditures and documents underlying those expenditures must be maintained for a period of at least 5 years
- Supporting documentation must be submitted with any request to the County for Opioid Settlement funds
- Actual invoices must be submitted to the County to receive reimbursement
- For salary reimbursement, payroll records must be provided in support of the time charged to the proposed program
- Each program funded will be required to submit quarterly performance reports. Reports must contain information to describe progress, update program objectives on intended or actual impacts, and provide performance data.
